Aide Memoire

A World Bank implementation support mission for the *Lao PDR: Second Lao Environment and Social Project* was conducted from October 26 to November 13, 2020. We would like to thank all participants and agency counterparts for their cooperation, and for their flexibility to hold meetings virtually. We would also like to thank the Environmental Protection Fund (EPF) for coordinating the mission. We are pleased to share with you the attached Aide Memoire, summarizing the key outcomes of the mission and agreed next steps for the above referenced project. Key issues are summarized below.

- 1. LENS2 implementation progress remains moderately satisfactory. Disbursements and project objectives are largely on track and M&E reporting has gradually improved. Some financial management issues, however, have not been resolved namely selection of the new accounting software and improvement of the monthly reporting of expenditures by some subprojects. Several sub-projects will require implementation progress to accelerate in order to meet end-project targets, especially the village livelihood grants in the two national parks and the pollution control sub-project.
- 2. Achievement of a key project targets on the capacity to investigate wildlife crimes that is critical for the success of LENS2 is lagging, despite solid detection efforts. The respective agencies require stronger interagency organization and cooperation at both national level and provincial level to assist effective investigations and prosecutions.
- 3. We would highly appreciate receiving more information regarding potential development activities within and around the Nakai Nam Theun and Hin Nam No National Parks which might undermine the success of the LENS2 project.

- 4. As LENS2 enters the last year of implementation, and after having been extended to June 30, 2022, raising the LENS2 overall performance rating to *Satisfactory* requires clear progress on the above issues while ensuring the project's successful outcomes are preserved.
- 5. The mission discussed with MONRE and the Ministry of Public Works and Transport a potential new investment project on environmental and solid waste management. We look forward to receiving the request letter from MOF.

We value our close partnership with the Government of Lao PDR in achieving LENS2 objectives.
